NOTICE

Subject: Submission of online proposals for approval of fees as well as to opt for 'No Upward Revision' of fees for the Academic Year 2026-2027.

Ref: Authority resolution dated 18/09/2025.

All the Unaided Private Professional Colleges/Institutions running the graduate and/or post graduate courses affiliated to the University within the State of Maharashtra are hereby notified that the link for submission of the proposal for approval of fees as well as to record option to opt for 'No Upward Revision' of fees for the academic year 2026-2027 shall be open w.e.f. **19th September 2025** and same shall remain open till midnight of **31st October 2025**.

The Institutes/Colleges are directed to submit the online proposal for approval of fees or opt for 'No Upward Revision' of fees on and before the due date i.e., 31st October 2025 as prescribed u/s 14(1)(a) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (hereinafter referred to as 'the said Act of 2015') to enable the Authority to decide the proposals expeditiously.

The Institutes/Colleges can submit online proposals for academic year 2026-2027 based on Audited Financial Year 2024-2025 by accessing the portal and using the user-id and password provided by the Fees Regulating Authority to respective Institutions and already registered.

The Link for submission of the online fees proposal to Institutes/Colleges who are already registered is as under:

Go to www.mahafra.org -> click on the menu **Online Fees Proposal Application - > Click on "Submission of Online Fee Approval Proposal Academic Year 2026- 2027."**

The Colleges/Institutions which are not already registered with the Fees Regulating Authority as well as new colleges are required to first register with the Fees Regulating Authority and secure their user-id and password. Only after securing the user-id and password, they will be entitled to access the link provided on the portal for submission of the online proposal. After registering and securing user-id and password the Colleges/Institutes will be entitled to submit online proposals for approval of fees.



The new Colleges/Institutes or the colleges which are not already registered with the Fees Regulating Authority can register and submit the proposal as under:-

Go to www.mahafra.org -> click on the menu **Online Fees Proposal Application** -> Click on "New College Registration" and then fill up the registration form by filling in the required information. After the registration, the concerned College/Institute will be provided with user-id and password which is to be used for submission of online fee proposals by accessing the portal.

All Colleges/Institutes are to take note that the processing fee shall be accepted only through the online payment gateway and cheques or demand drafts shall not be accepted. The copy of the receipt generated after payment of the processing fee shall be submitted with the hard copy of the proposal as proof of payment of the processing fee. The proposal submitted without payment of processing fees shall not be entertained and processed.

After submitting the online proposal, **the Institute shall submit a hard copy of the online fee proposal within 15 days as per Index and properly paginated.**

All the Institutes/Colleges are requested to go through the norms prescribed by the Authority for fixation of fees for the academic year 2026-2027 before undertaking the process of submitting online proposal.

If any Institute/s or College/s fails to submit proposal within the period prescribed, then such act of Institutes/Colleges will amounts to contravention of the provision of the said Act of 2015 and liable for penal action as provided **u/s. 20 of the said Act of 2015.**
