Heard the Institute.

The college/Institute has given notice dated 2/06/2013 to the students/parents as per our resolution, but none is present. Notice is produced.

The only error pointed out is in the making the demand by the Institute. The demand made was Rs. 35,000/-. Therefore the fee declared was Rs. 35,000/- as it was less than our calculation. But it is pointed out that the demand was infact Rs.70,000/-. It seems to be a bonafide mistake on the part of the Institute.

However the Institute has now given a letter dated 13/06/2013 stating that the fee may be declared for 2012-13 course at Rs. 53,000/- as it is the minimum amount required to run the course. We feel that the demand is quite just and reasonable. Hence we grant it. Office to declare as per our practice for RANM course.

Item No. 5: To Consider and decide the Letter dated 6/06/2013 received from Sharad Jaysingh Patil, in respect of Siddhakala Ayurvedic College, Sangmner regarding refund of Admission fees.
