It is brought to the notice of the Authority that the notification declaring B.B.A, B.B.M, B.M.S & B.C.A courses as Professional Educational courses by the State Government of Maharashtra is yet to be received.

In order to apply the regulatory mechanism in terms of the provisions of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees)Act, 2015 (hereinafter referred to as 'the said Act of 2015'), it is necessary to issue notification u/s. 2(r) of the said Act of 2015 to declare the said courses as 'Professional Courses'.

Hence the Officials are directed to send reminder to Concern Official to make available the copy of notification declaring the said courses as professional courses to enable the Authority to take necessary steps in the matter.

Let the follow up action be taken as directed".
