1. D 5294: Asian Institute of Pharmacy, Nashik

Heard the institute.

The fee approved for the students who joined during 2011-12 was Rs. 46,070/-. The institute has demanded fee of Rs. 50,000/- for students who joined during 2012-13. The fee as per our calculation comes to less than that. At the time of hearing it is stated that they have collected about 50% of the fee only. The institute has now given a letter dated 31st August 2012 stating that the fee may be approved at Rs. 35,000/- for the students who joined during 2012-13. It is also stated that it is necessary considering the expenditure required. We feel that it is reasonable. We approve the fee of Rs. 35,000/-. If the institute has collected any fee over and above Rs. 35,000/- from any students who joined during 2012-13 then the same to be either refunded to him or adjusted in the next year's fee.

B. Tech. Town & Country Planning is a new course to be started during 2012-13. The permission is granted on self-financing basis though other courses are granted Government aid. Therefore, college can charge ad hoc fee of Rs. 49,600/- from these students. Finally fee can only be approved after submission of audited accounts at the end of the next year. Therefore, the demand made in the said letter to allow to recover the fee of Rs. 71,964/- from each student can not be accepted at this stage. This ad hoc fee mentioned above is applicable to all new B. Tech. courses started by any college during 2012-13 and hence no exception can be made. The fee finally approved is based on actual expenses incurred.
