**RESOLUTIONS**

- (1) WHEREAS this Authority under Section 11(2) of the Maharashtra Unaided Private Professional Educational Institutions Act, 2015 is declared as the legal entity and an autonomous body in the matter of discharge of its function specified under the Act AND  
WHEREAS the Government of Maharashtra vide Order dated 4<sup>th</sup> August 2015 has created various posts including the post of Under Secretary in the Scale of 15600-39100+6600 AND  
WHEREAS this Authority from time to time requested the Government to make available services of the staff on deputation basis AND  
WHEREAS the services of ministerial staff except Accounts Officer have not be made available to this Authority till date AND  
WHEREAS considering the magnitude and volume of work and having regard to the administrative exigency it is felt necessary to fill up on urgent basis the posts sanctioned by the Government vide Order dated 4<sup>th</sup> August 2015 AND  
WHEREAS one Mr. Shankar Shamrao Padhal who retired on 30.09.2012 from the post of Deputy Secretary, Women & Child Development Department, Mantralaya, Mumbai has applied for appointment to the post of Under Secretary in the scale of 15600-39100+6600 on Pay minus pension basis as provided under Maharashtra Civil Services (Pension) Rules AND  
WHEREAS this Authority having considered the resume and long experience of Mr. Shankar Shamrao Padhal has decided to avail his services (on contract) Pay minus Pension basis for a period of one year. The Authority has unanimously authorized the Secretary of this Authority to issue Appointment Order subject to verification of his ACR preceding three years of his retirement. Before issuing order of Appointment, the Secretary shall request the concerned department to make available copies of ACRs preceding three year of retirement of Mr. Shankar Shamrao Padhal. Initially, appointment shall be for one year, terminable by one months notice on either side.

- (2) This Authority has authorized Shri Ravindra Dahad, Member, to explore possibility of availing services of Chartered Accountants and Cost Accountants to constitute scrutiny cells. It is reported that, firms and individual have expressed interest to work in the scrutiny cell. In this regard, a committee consisting of Mr. Sanjay Panse, Mr. Ravindra Dahad and Mr. Tummod is constituted to interview the candidates preferably in Mumbai and identify suitable person. Persons so identified shall constitute panel, whose services will be availed of as and when required. It is further resolved that services of retired District Judge's and experts in the respective fields be availed to oversee work of scrutiny cell. After this exercise is over, remuneration to be paid to members of scrutiny cell shall be decided.

**Proposals for the Academic Year 2016-17:**

Introduction of paperless system is under serious consideration of FRA. Practice of receiving on line application is likely to be introduced. Some changes in formats to be used while submitting application are in offing. Institutions shall wait till further announcement. However, they shall be ready with online application, if at all, they desire to submit proposal for fixation of fees for the year 2016-17.
