ii) **Resolutions:****(1) Clarification:**

This authority is in receipt of queries regarding fees to be collected from the students directly admitted to 2nd year against lateral entry-vacancies.

The issue has been discussed in the meeting dated 27th March, 2018 and following clarification is issued.

Illustration: If fees for Engineering Course A.Y. 2017-18 is declared as Rs.80,000/-, it shall remain the same till completion of the course. In the A.Y. 2018-19 the student is admitted to 2nd year through lateral entry then the fees for him shall be the fees applicable to the regular student that means Rs.80,000/-.


With above principle it is ensured that whatever fee is declared for the batch of 2017-18 that is Rs.80,000/- shall continue to apply to the regular students as well as to the student directly admitted to 2nd year through lateral entry.

(2) Queries are also received about the fees to be collected from the repeater students. In this regard the then Shikshan Shulka Samiti on 3rd January, 2014 took following decision :

"Considered the letter dated 10/10/2013 received from Dadasaheb Surupsing Naik Ayurvedic Mahavidyalaya, Dhule. It is in respect of fee to be collected from repeater students. The College can collect the fee from such students pro-rata of the failed subjects (for example if the fee is Rs.1,00,000/- and there are five subjects, if a student fails in two subjects and is required to appear again for those two subjects, then college can charge Rs.40,000/-) for which they are required to appear again.

It is clarified that the decision ~~is~~^{is} dated 3rd January, 2014 to the above extent shall continue to apply.
