Minutes of the 120th Meeting of the Fees Regulating Authority (constituted under section 11(2)(3)(4) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation Admissions and Fees) Act, 2015) held on **Tuesday, the 16th October, 2018 at 10:30 a.m.** in the Conference Hall, Room No. 305, Government Polytechnic Building, 49 Kherwadi, Ali Yawar Jung Marg, Bandra (E), Mumbai - 400 051.

Item No. 1 : To confirm the minutes of the 119th Meeting of the Fees Regulating Authority.

The Minutes of the 119th Meeting dated 20th September, 2018 of the Fees Regulating Authority are confirmed and approved.

Item No. 2 : To discuss in the matter of finalizing norms for academic year 2019-20

Discussed. Amendments suggested to be considered and finalized in the next meeting.

Item No. 3 : To consider and decide on grievances received from the students/parents/colleges.

- (i) **To consider and decide on letter dated 22nd September, 2018, received from the Principal Indira College of Pharmacy regarding to finalize fees for Pharm. D for academic year 2016-17 and 2017-18.**

Read communication dated 22/8/2018 received from Indira College of Pharmacy, Pune.

The college is running Pharm. D course which is of six years duration. On the basis of the proposal submitted, fee structure for the academic year 2018-19 was approved at Rs. 1,25,000/- per student per year till completion of the course.

The college opened in the academic year 2016-17. Therefore fees for academic year 2016-17 and 2017-18 were collected on the adhoc basis. However, while approving fee structure for the academic year 2018-19, fees structure for the academic year 2016-17 & 2017-18 remained to be approved/confirmed. The college collected Rs. 1,10,000/- as adhoc fees for both the academic years. This is reasonable in view of the fact that denominators for the earlier academic years were smaller.

Therefore, the fee structure for Pharm.D course for academic year 2016-17 and 2017-18 shall be Rs. 1,10,000/-.

Item No. 4 : Any other matter with the permission of the Chair.

- (i) **To consider and decide on letter dated 25th September, 2018, received from the Principal, Karmaveer Adv. Baburao Ganpatrao Thakare College of Engineering, Nashik asking to give guidance in Shikshan Shulka Samiti Higher and Technical Courses norms for academic year 2013-14 dated 1st April, 2013, on page no.1, point no.1.1.5.**

Read communication dated 25th September, 2018, received from Karmaveer Adv. Baburao Ganpatrao Thakare College of Engineering, Gangapur Road, Nashik.

Sub : Fees to be charged from the student who is unable to complete the course within specified duration i.e. repeaters.

The Shikshan Shulka Samiti in its meeting dated 1st April, 2013, decided thus :

"In case the students take 5th years from completing the 4th year course then he shall pay the fee approved in that year."

Section 14(6) reads thus:

"The fees approved and communicated by the Fees Regulating Authority shall be applicable in respect of the candidate who is admitted to the unaided institution in that academic year and shall not be revised till the completion of the course of such student in the concerned institution."

In view of the above, if a student is required to attend the classes in subsequent years, the fees initially applicable to a particular student shall continue to apply even if he does not complete the course within specified course duration.

Illustration :

The approved fees for B.Engg. course for A.Y. 2016-17 is Rs.1 Lakh. Duration of the course is of 4 years i.e. till A.Y. 2019-20. If such student did not complete the course in the A.Y. 2019-20, and is required to attend classes in the subsequent academic year i.e. 2020-21, 2021-22, the fees to be charged from such student shall not vary but remain the same i.e. Rs.1 Lakh.

Above clarification is issued insupercession of all earlier resolutions, clarifications issued in this behalf.

- (ii) **To consider the letter dated 1st August, 2018, received from Kai. Ramrao Patil B.Sc. Nursing Mahavidyalaya, Udgir, Latur regarding fixation of fees for AY 2018-19.**

Read letter dated 15th October, 2018, received from Late Ramrao Patil B.Sc Nursing College, Udgir, Latur seeking adjournment. Granted.
