- (a) **To correct the minutes of meeting dated 22/07/2025 in declaring the fees of M.D/M.S course run by Padmashri Dr. Vithalrao Vikhe Patil Medical College, Ahmednagar (MBBS0009) for the academic year 2025-2026.**

"Discussed.

It was brought to notice that there was a typographical mistake in minutes of meeting dated 22/07/2025 in declaring the fees of M.D./M.S course of the above-mentioned College/Institute for the academic year 2025-2026. After considering, the Institutional & Management Quota the fee was worked out less than the 'De minimis' fees prescribed by the Authority i.e. Rs. 9,00,000/- per student. Since the fees worked out was less than the De minimis fees on account of consideration of additional income generated by way of Management and N.R.I Quota, the Authority has decided to approve the 'De minimis' fees for the said course. However, by mistake the De minimis fees came to be typed as "Rs. 10,00,000/-" instead of "Rs. 9,00,000/-". It was therefore decided to rectify the mistake and correct the figure Rs. 10,00,000/- (De minimis) as "Rs. 9,00,000/- (De minimis) " in the minutes of meeting dated 22/07/2025. Accordingly, the corrigendum be issued to the minutes of meeting dated 22/07/2025 & the Institute be informed about the rectification of mistake & correction made".

- (b) **To correct the minutes of meeting dated 23/07/2025 in declaring the fees of Bharatratna Atalbihari Vajpayee Medical College and Hospital, Pune (MBBS1157) in respect of M.B.B.S. course for the academic year 2025-2026.**

"Discussed.

It was brought to notice that the Authority has considered the proposal of the above-mentioned College/Institute and determined the fees for the academic year 2025-2026. After considering the additional income generated from the students admitted under Management and N.R.I Quota the fee was worked out less than the 'De minimis' fees of Rs. 7,50,000/-. Since the fees worked out was less than 'De minimis' fees of Rs. 7,50,000/- the Authority has decided to approve the fees of Rs. 7,50,000/- per student as 'De minimis' fees for the academic year 2025-2026. However, in the minutes of meeting dated 23/07/2025 the word 'De minimis' remains to be recorded below the figure Rs. 7,50,000/- & therefore the minutes of meeting be corrected and figure "De-minimis" be recorded below the figure 'Rs. 7,50,000/-' in respect of fees approved of Bharatratna Atalbihari Vajpayee Medical College and Hospital, Pune (MBBS1157) for the academic year 2025-2026.

In view of above the minutes of meeting dated 23/07/2025 be rectified and below the figure Rs. 7,50,000/- the word "De minimis" be recorded in the minutes of meeting dated 23/07/2025 & necessary corrigendum be issued".
