Item No. 3: Any other matter with the permission of the chair.

- i) **To consider the letter dated 10/12/2018 received from Shri Swami Samarth Institute of Pharmacy, Dhamangaon, Amravati regarding fixation of fees for the academic year 2016-17 and 2017-18.**

Read communication dated 10/12/2018 received from Shri Swami Samarth Institute of Pharmacy, Dhamangaon, Dist – Amravati.

The college is running D. pharmacy course since year 2006-07. In the academic years between 2011-12 and 2014-15 there was no admission. In the year 2016-17 students were admitted. The college charged Rs. 48,000/- from the student belonging to batch 2016-17 and 2017-18. The fees proposal for A.Y. 2018-19 was submitted. This Authority approved fee of Rs. 52,000/-.

This is a case of confirmation of adhoc fees collected from the student belonging to 2015-16 and 2017-18 batches. Having considered approved fee structure of Rs. 52,000/- for the A.Y. 2018-19, the adhoc fee of Rs. 48,000/- collected from the students belonging to academic year 2016-17 and 2017-18, appears justified and accordingly approved.

ii) **To consider the letter dated 23/11/2018 received from BRAC's Vishwakarma Institute of Information Technology, Kondhwa, Pune regarding fees to be collected from students admitted for Direct Second Year for Academic Year 2018-19.**

Considered communication dated 23/11/2018 received from BRAC's Vishwakarma Institute of Information Technology, Kondhwa, Pune

Contention of the college is "We have a separate division of 60 students for U.G. Course in Civil Engineering for SEDA (Second Year Engineering Direct Admissions) approved by AICTE from Academic Year 2011-12. As this division is not 'Lateral Entry' sanctioned by State Govt but a separate division approved by AICTE. The fees to be charged to these students should be the same as the freshly admitted students of First Year Level".

Prayer can not be accepted. Practically speaking there is no distinction between students admitted against lateral entry quota and students admitted to Second Year against Special quota sanctioned for directly admitted Second Year students. While approving fee structure overall income – expenditure is considered and one fee structure which applies for the entire course i.e. 4 years, is approved. For e.g. for the batch of students admitted in academic year 2018-19, fee structure remains the same till entire course is completed. Therefore, there can not be different fee structure for the students directly admitted in the academic year 2019-20. In fact, they join the batch of 2018-19 and therefore, fee structure fixed for academic year 2018-19 shall apply to them.

iii) **To consider of communication dated 4/12/2018 received from Rohidas Patil Institute of Management Studies, Bhayandar Dist -Thane.**

Read this office memo dated 15/11/2018 issued to the Rohidas Patil Institute of Management Studies, Bhayandar and reply the dated 4/12/2018 received from the college.
