In brief it is contended that the Authority has disallowed the salary of Hospital staff while considering the fees. On due consideration of the submission in the light of record the Review Application filed is devoid of merit. It is pointed out to the Officials that the Institute has claimed the hospital deficit of Rs. 19,20,838/- which has been allowed by the Authority.

It is further pointed out that the same amount has been claimed separately as a hospital staff salary, hospital expenses and property tax. After hearing the Officials present submitted that they are satisfied with the salary expenditure of the hospital has been duly considered by the Authority which has been claimed under the head of hospital deficit. The Officials submitted that they be allowed to withdraw the Review Application.

Allowed to withdraw.

The Review Application is disposed of as withdrawn".

It is contended that though the fees of the Institute has been worked out Rs. 94,204/-. The Authority has approved the fees of Rs. 86,000/- per student by giving reasonable rise over the previous year fees. It is submitted that the fees of the Institute in the academic year 2022-2023 was Rs. 80,000/-. Due to impact of the COVID-19 the expenditure were considerably reduced during the academic year 2023-2024 . Therefore the fees of the Institute was fixed on lower side of Rs. 96,500/-.

It is submitted that Operational cost of the Institute is about Rs. 81,000/- which is close to fees approved. Considering the increase and expenditure during the next 4 ½ years the fees of the Institute be revised and the fees worked out by the software due as a reasonable fees. On due consideration of the submission in advance the Authority is of the view that the Review Application is partly allowed, the reasonable rise has been given by considering the fees of previous year. During the academic year 2022-2023 the fees of the Institute was Rs. 80,000/-per student. The Operational cost of the Institute is about Rs. 81,000/-. It was therefore decided to partly allow the Review Application & revised the fees as Rs. 90,000/- per student by considering the fees of the earlier year and Operational cost.

Accordingly the Review Application is partly allowed. The fees of the Institute is revised as Rs. 90,000/- per student for the academic year 2024-2025 as under:-
