To consider the proposal of Dyanganga College of Engineering & Reserch, Narhe Ambegaon (EN6298) run by Zeal Education Society's Pune seeking approval of fees in respect of B.Engg., M.Engg. & M.B.A courses for the academic year 2024-2025.

"Discussed.

While examining the proposal for approval of fees it was noticed that the salary expenditure of teaching faculty employed by the Institution in the Financial Year 2022-2023 was about 11.9 crores. During the same period the expenditure on account of non-teaching staff employed on contractual basis by the Institution was about 14.24 crores. It is beyond the comprehension of the Authority to accept that the salary expenditure of non teaching staff to be more than the salary expenditure of teaching staff. In general, the salary expenditure of non teaching staff is much less than the salary expenditure of teaching staff. It is generally in the rate of 30 to 40 percent of the salary expenditure of teaching staff. The Institute though claimed to have employed contractual employees and paid more than 12 crores the Institute has not provided the details of amount paid to category of individual employed on contractual basis, G.S.T invoices raised by the contractor, the amount paid to contractor, the G.S.T amount deducted and paid, the form no. 16 A are not supplied. So, also the Institute has not provided segmental bifurcation of income and expenditure of F.R.A and non F.R.A courses run by the Institute, the income and expenditure of the Hostel & the Trust. The Institute has claimed expenditure of Rs. 53 lakhs made towards academic meeting which is comparatively on higher side. Similarly, the expenditure claimed to be made towards Demonstrative material and

Laboratory material is on higher side. The Institution has claimed Rs. 87,26,897/- spend towards Training & Placement without providing particulars and supporting evidence. Similarly, is the position about the expenditure claimed towards furniture and repairs. In order to decide the reasonable fees of the Institute it was decided to direct the Principal of the college to provide the following documents;

1. The Agreement with the contractor, the rates prescribed for contractual appointment of various category of the persons to be employed on contractual basis. The number of persons employed on contractual basis with categorisation designation, the monthly amount paid towards individual service, the invoices raised by the contractor, the amount paid together with G.S.T, copies of G.S.T return filed, Form No. 16A of the Financial Year 2022-2023.
2. Provide the item wise list of the expenditure towards repair maintenance of building, furniture repairs and maintenance, annual maintenance contract, demonstration material, laboratory material, training & placement, induction programme and authenticated bills and invoices and proof of payment towards said expenditure.


The Institute be directed to furnish the information within eight days. Failure to comply the Authority may proceed to decide the proposal by treating that the Institution/College have no explanation to be offered.

It is brought to notice that the Institutions/Colleges mentioned below though submitted online proposal for approval of fees for the academic year 2024-2025 but till this date they have not submitted the hard copies of the proposal inspite of repeated reminders.

In view of default on the part of the Institutions/Colleges mentioned below the Authority is unable to decide their proposals for approval of fees. Such act of the Institutions/Colleges invite penal consequences enumerated u/s. 20 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015. Before taking the further action, it was decided to grant one more opportunity to them to comply the direction. The letter be issued to the Principal of the Institutions/Colleges of individual Institutions to submit the hard copies of the proposal within eight days & with clear understanding that failure to comply the direction the Authority may consider to report the names of such Institutions/Colleges to Admissions Regulating Authority and Other Competent Authority for taking appropriate action at their level including the action to debarr such Institutions from participating in admission process.


