Item No. 2(i):

To consider the proposal for approval of fees of Gurukrupa College of Physiotherapy, Majalgaon, Beed (PT06375) running B.Pth course for the academic year 2024-2025.

"Discussed.

the proposal it was noticed that the examining While Institute/College has started functioning from the academic year 2021-2022 and charged the adhoc fees of Rs. 80,000/- per student. In the next academic year 2022-2023 the Institute has charged and collected adhoc fees of Rs. 85,000/- per student. The Institute was under statutory obligation to submit the proposal for approval of fees for the academic year 2023-2024 based upon the audited financial statement of the academic year 2021-2022. However the Institute/College has not submitted the proposal for approval of fees as mandatory required u/s. 14(1)(a) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees)Act, 2015 (hereinafter referred to as 'the said Act of 2015') for approval of fees for the academic year 2023-2024 and finalisation & confirmation of adhoc fees of the academic year 2021-2022 and 2022-2023. The Institute has directly submitted the proposal for academic year 2024-2025. By making default in submitting the proposal for the academic year 2023-2024, the Institute has committed breach of provisions of the said Act of 2015 and thereby liable for action u/s. 20 of the said Act of 2015. In absence of proposal for approval of fees for the academic year 2023-2024, the proposal for approval of fees for the academic year 2024-2025 cannot be decided. In view of prima facie case being made out of breach of mandatory provisions of the said Act of 2015, it was decided to issue show cause notice to the Principal and Management running the Institute calling upon them to explain as to why the action as contemplated u/s. 20 of the said Act of 2015 may not be taken against them. The explanation be submitted within seven days from the date of receipt of the notice. Failure to submit the explanation the Authority will presume that the Institute/College has no explanation to offer in the matter.

Let the follow up action be taken as directed".

Item No. 2(ii):

To consider the proposal for approval of fees of Shri Gurudatta Pratishthan Nanded's Nanded Physiotherapy College and Research Center, Nanded (PT6332) running B.Pth course for the academic year 2024-2025.

"Discussed.

While examining the proposal and considering the fees reconciliation statement it was noticed that Institute/College has collected Rs. 35,12,531/in excess than the fees to be charged and collected from the students

during the academic year 2021-2022 & 2022-2023. In order to ascertain the factual position as to excess collection of the fees, it was decided to seek explanation and clarification from the Principal of the Institute. The Institute be directed to submit the fees reconciliation statement in the prescribed proforma and offer the explanation as to collection of excess fees from the students.

The explanation be submitted within one week from the date of receipt of communication. Failure to submit the explanation it will be presume that Institute has no explanation to be offered in the matter and the Authority will decide the proposal .

Let the follow up action be taken as directed".

Item No. 2(iii):

To consider the proposal for approval of fees of Aditya College of Physiotherapy, Beed (PT06366) running B.Pth course for the academic year 2024-2025.

"Discussed.

While examining the proposal it was noticed that Institute/College has started functioning from the academic year 2021-2022 and charged & collected the adhoc fees of Rs. 80,000/- per student. In the next academic year 2022-2023 the Institute has charged and collected the adhoc fees of Rs. 80,000/- per student.
