### Item No. 4: Any other matter with the permission of chair.

i) To consider letter dated 24/4/2018 received from Deputy Secretary, Medical Education and Drugs Department, Mumbai regarding multiple fees structure for PG course in Medical Colleges.

## Ref: Decision dated 19/3/2018 about multiple structure fees.

The Government considers it appropriate for the Institutions/Medical Colleges to collect fees with upper limit of four times the regular fees from the students admitted against Institutional/Management quota in Medical PG courses.

It is believed that the Government has legitimate reason and necessary data to suggest increase in the fee structure for Institutional/Management quota students. This Authority does not see any reason not to accede to the suggestion made by the Government.

Accordingly, Office to communicate above decision to the concerned and also place it on the website of this Authority .
