Item No.2(ii): The proposal for approval of fees of Shri Gulabrao Deokar College Of Nursing, Jalgaon (BSCN09189) for the academic year 2024-2025 in respect of B.Sc.(Nursing) course.

"Discussed.

While scrutinizing the proposal it was noticed that the Institute/College has submitted the proposal for approval of fees for the academic year 2024-2025. The Institute has not submitted proposal for academic year 2023-2024.

The Institute has charged the adhoc fees for the academic year 2021-2022 and 2022-2023. The Institute was expected to submit the proposal for approval of fees for the academic year 2023-2024 and finalization and confirmation of fees for the academic years 2021-2022 & 2022-2023. Due to the default the Management running the Institute/College has committed breach of mandatory provisions of law and liable for penal action u/s. 20 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (hereinafter referred to as the said 'Act of 2015').

Hence the Institute be directed to submit explanation within seven days as to default in submitting proposal for academic year 2023-2024. The proposal submitted for approval of fees for the academic year 2024-2025 be kept pending till receipt of the explanation.

Inform to concern Official of the Institute/College".

Item No.2(iii): The proposal for approval of fees of SBNM'S Mauli Nursing College, Hatta, Hingoli (BSCN09362) for the academic year 2024-2025 in respect of B.Sc.(Nursing) course.

"Discussed.

While examining the proposal it was noticed that within a year the salary expenditure of the Institute/College has increased twofold. In the proposal submitted for the approval of fees for the academic year 2023-2024 based upon Audited Financial Statement the Institute/College has shown total salary expenditure to the tune of Rs. 1.06 crore. Whereas in the proposal submitted for the academic year 2024-2025 based upon Audited Financial Statement of 2022-2023 the salary expenditure shown as Rs. 2,03,00,000/-. Thus, there is abnormal increase in salary expenditure to the tune of about Rs. 1.0 crore. Hence the explanation be obtained from the Institute.

The Institute/College be further directed to submit the income tax assessment order of each of the staff member and Bank statement with entries duly marked of the salary paid to employees.

Item No.2(iv): The proposal for approval of fees of Sant Gajanan Maharaj College Of Nursing, Mahagaon-Site, Kolhapur (BSCN9188) for the academic year 2024-2025 in respect of B.Sc.(Nursing) course.

"Discussed.

While examining the proposal for approval of fees submitted for the academic year 2024-2025. It was noticed that Institute has not submitted the proposal for approval of fees for the academic year 2023-2024 and finalization and confirmation of adhoc fees charged for the earlier two years.

Hence issue show cause notice to the Management running the Institute/College seeking explanation for committing the breach of statutory provisions of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees)Act, 2015. The Institute/College be directed to furnish explanation within seven days.

The proposal for approval of fees for the academic year 2024-2025 cannot be decided unless the proposal for approval of fees of the earlier period is finalized. Hence the proposal for approval of fees for the academic year 2024-2025 be kept pending till the explanation is received from the Institute/College.

Let the follow up action be taken accordingly".
